

LEGAL NOTICE

In this notice (hereinafter, the "Legal Notice"), the website user (hereinafter, the "User"), will find all the information regarding the legal conditions that define the relationship between the users and the owner of the website accessible at the URL address www.evanhub.com (hereinafter, the "Website"), which EVANHUB (hereinafter, the "Owner") makes available to internet users.

Use of the Website implies full and unreserved acceptance of each and every provision included in this Legal Notice. Consequently, the Website user must carefully read this Legal Notice each time they intend to use the website, as the text may undergo modifications at the discretion of the Website Owner, or due to legislative, jurisprudential, or business practice changes.

The Owner is responsible for the Website and is committed to complying with all national and European requirements governing the use of users' personal data.

This Website guarantees the protection and confidentiality of the personal data provided to us in accordance with the provisions of the General Data Protection Regulation (EU) 2016/679 of the European Parliament and of the Council of April 27th, 2016, in Organic Law 3/2018, on the Protection of Personal Data and guarantee of digital rights, as well as in the Law on Services of the Information Society and Electronic Commerce 34/2002 of July 11th (LSSI-CE), these last Spanish laws.

2.- SCOPE

The Website provides users with access to information and services provided by the Owner to those people or organizations interested in them.

Access to and use of the Website attributes the condition of User of the Website and implies acceptance of all the conditions included in this Legal Notice as well as its modifications. The provision of the Website service has a limited duration to the moment in which the User is connected to the Website or to any of the services provided through it.
